

## Summary of Non-Probationable Offenses

SPAC has identified offenses for which probation, periodic imprisonment, and conditional discharge cannot be imposed pursuant to 730 ILCS 5/5-5-3 and offenses with sentencing provisions stating that term of imprisonment shall be imposed. These are the offenses to which a mandatory minimum prison sentences apply. For reference, the table to the right provides the presumptive sentence range by felony offense class.
